# CONDITIONS OF SALE

## 1. Application

These conditions apply to all sales of wines by Dynamic Vines Ltd to any customer (a "customer") and apply in place of and prevail over any terms or conditions put forward by any Customer.

## 2. Wines and Prices

Prices are subject to alteration without prior notice. Prices are quoted per bottle unless indicated otherwise. The D.P. Price is offered Excise Duty and clearance paid £26.76 and excluding VAT and delivery. Where applicable, VAT will be included at the prevailing rate. The minimum order is two cases (24 bottles in London and 48 bottles Mainland UK) unless indicated otherwise.

## 3. Placing an order with us

An account must be applied for with us and we will inquire of your organisation and directors with a credit reference agency before approving an Account and accepting orders. We reserve the right to denying applicants an account or any facilities with our company without explanation. We also reserve the right not to accept orders from Account holders without explanation.

## 4. Availability

Every effort will be made to ensure that all wines (other than those marked limited quantity) remain available until publication of the next list. However, in the event of your order including a wine that is not available, we will, unless instructed to the contrary, select a replacement as near as possible in style, quality and price.

## 5. Title of Goods

All the goods shall remain our property until payment in full is received by Dynamic Vines Ltd (together with any interest payable in respect thereof) for the goods and no other amounts then being outstanding from the Purchaser to Dynamic Vines Ltd in respect of other goods supplied to the Purchaser by Dynamic Vines Ltd. In the event of non-payment we reserve the right, without notice, to enter any premises owned or occupied by the Purchaser in order to recover all or any of the goods. The Purchaser agrees to keep goods identifiable as the property of Dynamic Vines Ltd and to keep them stored in merchantable condition. The goods will be held by the Purchaser as bailee and agent for Dynamic Vines Ltd until full payment has been made.

## 6. Claims

All goods must be examined carefully at the time of collection or receipt of delivery with the delivery person present and any shortages or damage recorded and signed on the delivery or carrier's note. Any claims must then be made to us within 48 hours of delivery by telephone or in writing. We regret we cannot accept claims that are not recorded or reported in this way.

## 7. Payment

Full payment is due 30 days from date of invoice. If payment is not made when due, then Dynamic Vines Ltd may without prejudice to its other rights, charge interest at an annual rate of 2% above the current U.K base rate to be calculated on a day basis on the balance outstanding until payment is made in full.

## 8. "Force Majeure"

The company will not be liable for any failure or delay in performing its obligations caused by any circumstances which are beyond its reasonable control.

## 9. Law

All our contracts are subject to English law and jurisdiction.

## 10. Delivery

The delivery and handling charge for Excise Duty and VAT paid goods to a destination within Greater London is £16.00 + VAT for orders under 24 bottles; for other amounts, please apply to us for a quote. Outside of Greater London, a varying charge will be made according to the amount ordered, the destination means of transport and packing required, please apply to us for a quote. For deliveries of goods Under Bond, please apply to us for a quote. Customers are also welcome to pick up their orders from us but this has to be arranged beforehand.
